Supporting Your English Learner Child

This resource provides information on how to support children of families new to the United States or those who have multilingual children. It is not intended to be an exhaustive list. Always check with your child's teacher and school for any specific questions about your child's progress at school.

Based on the responses on the Home Language Survey, your child was identified to take an initial English language proficiency test. Your child took either the Initial English Language Proficiency Assessments for California (ELPAC) or the Initial Alternate ELPAC, and the results showed a need for support with learning English.

Ways to Support Your English Learner Child

- Talk to your child about the assessment. Make sure your child knows that these assessments are important, but they are just one measure of learning. The teacher uses that information along with other information to make sure your child is getting the support they need.
- Practice English together.
- Continue literacy and language development in your home language.
- Instead of asking your child to translate school documents or conversations, ask the school for a staff member to translate.
- Find out about your school's English Learner Advisory Committee (ELAC) meetings.

Questions to Ask Your Child's Teachers

- When will the ELPAC be administered again?
- Which other assessments, such as benchmark and interim assessments, are being used to measure my child's progress in English Language Development (ELD) throughout the year?
- What ELD instruction is being provided to help my child at their English proficiency level?
- What supports are provided in other subject areas to help my child learn English?
- What are the impacts to academic instruction on my English learner child, such as pull-out and push in instruction or loss of electives?

What You Need to Know About Reclassification

Reclassification is the process for English learner students to exit support programs and services once they meet all reclassified fluent English proficient criteria. It is important to talk to your child about their goals for reclassification and biliteracy. You can learn about reclassification by asking your child's teacher, attending your school's ELAC meetings, and visiting the California Department of Education (CDE) Reclassification FAQs web page at https://www.cde.ca.gov/sp/el/rd/reclassificationfags.asp.

Ask about the support that will be available for your child after reclassification and about the impacts on your child's academic instruction once they are reclassified. You can request information about the monitoring process for reclassified students at the school/district.
